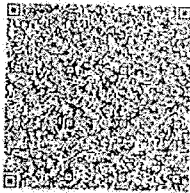
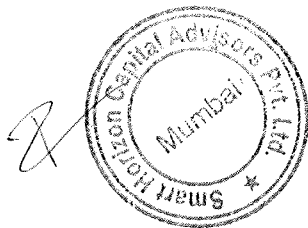

For Services rendered, the Company shall pay to LM fees as per the mandate dated September 20, 2024 and addendum to mandate letter dated November 01, 2025.

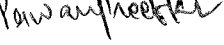
Marketing / underwriting fees shall be 8.03% of Fund Raised.
