#### NOTE ON THE PROCESS OF DUE DILIGENCE OF PURPLE WAVE INFOCOM LIMITED

We have been appointed as the Book Running Lead Manager for the proposed Initial Public Offer of **Purple Wave Infocom Limited** (the "Company" or the "Issuer"). As mandated under the SEBI (ICDR) Regulations, 2018, we herewith submit a brief note on the diligence process adopted by us:

## Current business background, about the Operational Structure and the Business Strategy:

We had visited the registered office situated at Plot no. 1 & 2, First Floor, Pocket A2, Sector 17, Dwarka, New Delhi - 110075;

We have inspected the Office Infrastructure, systems and procedures etc. w.r.t. the Company's business and objects for which the funds are being raised. We also have examined various documents including those relating to litigations, approvals, etc. and other Material documents in connection with the finalization of the Red Herring Prospectus pertaining to the said Issue.

We have had discussions with the Board of Directors, Promoters, KMP's, Senior Management ("Management') including the support staff regarding the business operations and related activities of the Company and gone through other documents / websites in order to further understand the actual procedures of business.

We have further bifurcated the Risks into Risks pertaining to the Internal Risk Factors of the Company and External Risk Factors.
